OLD BUSINESS

Cumberland Recycling Inc Preliminary/Final Land Development Plan – The plan was presented by Dawn Castle from Dawood. Mr. Geistwhite made a motion to approve the 5 waivers for the Cumberland Recycling Plan dated 5/1/07 revised 6/28/07. Chairman Shughart seconded the motion and it passed unanimously. Chairman Shughart list the conditions of the plan as follows: 1. Comments from Bud Grove of 6/25/07 must be satisfied, 2. Post security and developer's agreement with the Township, 3. revise the signature block on the plan, and then made a motion to approve the plan with those three conditions. Mr. Geistwhite seconded the motion and it passed unanimously.

NEW BUSINESS

2007-08 Health Insurance – Mrs. Justh presented the new figures to the Supervisors for the 2007-2008 insurance and how much more economical going into the co-op for the same coverage would save the township \$4,000.00 a month. Mrs. Justh stated that Phil Harmon the township's health insurance coordinator thinks that the township should go forward with this plan. The Supervisors would like this back on the agenda for July 27 at the workshop meeting.

Mr. Geistwhite explained that he had talked to Rick Revegno about an accident that occurred on **Trindle and South Middlesex Roads** where a township resident's son had been killed. Chief Sherman explained that Trindle is a state road and the state doesn't think it warrants any changes. The Township has made all the necessary improvements that were requested of us and South Middleton has made similar improvements on their side of the South Middlesex Road, also.

Mr. Geistwhite asked about the **"Do Not Block Intersection" signs**. Chief Sherman explained that they are here and they will be installed on Monday of next week.

Mr. Geistwhite asked about the **radios**. Chief Sherman reported that we are in the test faze.

Mr. Geistwhite commented that Mr. Carpenter wrote a good letter to the **Country Club** about the unapproved driveway entrance on to County Club Road.

Mr. Shughart made a motion to adjourn the meeting at 7:15 PM. Mr. Geistwhite seconded the motion it passed unanimously.
