(#97007) Reapproval Of Onkaar Associates Preliminary/Final Subdivision Plan – Mr. Capuano made a motion to reapprove Preliminary/Final Subdivision Plans submitted, by Onkarr Associates, prepared by GCW and Alpha Engineers last revised January 28, 1998, provided that all conditions and waivers are met of the motion of February 5, 1998. Mr. Shughart seconded the motion and it passed unanimously.

(#98006) Reapproval Of Onkaar Associates Preliminary/Final Land Development Plan – Mr. Capuano made a motion to reapprove the Preliminary/Final Land Development Plan submitted by Onkarr Associates subject to the waivers of the letter from Township Secretary Justh dated April 1, 1998.
