ORDINANCE NO. 2 -87

AN ORDINANCE AMENDING ORDINANCE NO. 5-81 REQUIRING
COMPLIANCE WITH FLOODPLAIN MANAGEMENT REGULATIONS
AS ENACTED IN SECTIONS 17.05 AND 1706 OF THE
MIDDLESEX TOWNSHIP ZONING ORDINANCE IN REGULATING
THE CONSTRUCTION AND MODIFICATION OF STRUCTURES
WITHIN FLOODPLAIN DISTRICTS IN MIDDLESEX TOWNSHIP

BE IT ENACTED AND ORDAINED and it is hereby enacted and ordained by the Board
of Township Supervisors in and for the Township of Middlesex, Cumberland County,
Pennsylvania, as follows:

SECTION 1: Ordinance No. 5-81 originally enacted on June 9, 1981, is hereby
amended by adding the following section to and supplementing Article III of said
Ordinance as follows:

Section III. 6 - Compliance with Floodplain Management Regulations as
Contained in Zoning Ordinance

- A. Notwithstanding anything to the contrary appearing in any other
part of Ordinance No. 5-81, the provisions of Section 17.05 and
17.06 of Article XVII of the Middlesex Township Zoning Ordinance
shall be deemed to control and the Zoning Officer shall demand
strict compliance therewith prior to his issuance of any Flood
Area Building Permits.

SECTION 2: If any sentence, clause, section or part of this Ordinance is for any
reason found to be unconstitutional, illegal or invalid, such unconstitutionality,
illegality or invalidity shall not affect or impair any of the remaining provisions,
sentences, clauses, sections or parts of this Ordinance. It is hereby declared
as the intent of the Board of Township Supervisors of this Township that this
Ordinance would have been enacted and adopted had such unconstitutional, illegal
or invalid sentence, clause, section or part thereof not been included herein.

SECTION 3: The provisions of this Ordinance shall be deemed to control over
any inconsistent or conflicting provisions of any other ordinance previously
enacted, and to the extent of any inconsistency or conflict, such previously
enacted, inconsistent or conflicting ordinance provisions shall be deemed to
be repealed.

SECTION 4: This Ordinance shall take effect as provided by law.
