AN ORDINANCE OF THE TOWNSHIP OF MIDDLESEX, CUMBERLAND COUNTY, PENNSYLVANIA AMENDING ORDINANCE NO. 4-97 WITH RESPECT TO RULES AND REGULATIONS FOR THE USE OF PARK AND RECREATION FACILITIES.

WHEREAS, the Board of Supervisors of Middlesex Township on April 2, 1997 enacted Ordinance No. 4-97 providing for rules and regulations pertaining to the use of parks and recreation facilities in Middlesex Township; and

WHEREAS, the Board of Supervisors of Middlesex Township desires to amend Ordinance 4-97 as provided for herein.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Township Supervisors in and for the Township of Middlesex, Cumberland County, Pennsylvania, and it is hereby enacted and ordained as follows:

SECTION 1. Ordinance No. 4-97 as enacted April 2, 1997 by the Board of Supervisors of Middlesex Township is hereby amended as follows:

A. Section 4, Prohibited Acts, is hereby amended as follows:

1. Paragraph J is hereby amended to provide in its entirety as follows:

J. Possession of a firearm in violation of Pennsylvania law and the possession of any bows and arrows, air guns, paint guns, slingshots, fireworks or lethal or dangerous weapons, unless sanctioned by Middlesex Township.

2. New Paragraph R is hereby added as follows:

R. The erection and/or use of bounce houses, other inflatable equipment, inflatable recreational slides or inflatable devices are prohibited. This prohibition notwithstanding, Middlesex Township may utilize such equipment

and devices at Township sponsored or Township arranged events where such equipment is provided by or through Middlesex Township.

B. Section 8 and Section 9 are hereby renumbered Section 9 and Section 10, respectively.

C. New Section 8 is hereby added as follows:

SECTION 8: AMENDMENT TO PROHIBITED ACTS

Subsequent amendments to Section 4 may be made from time to time by the Board of Supervisors by the adoption of a Resolution at a duly advertised public meeting of the Board of Supervisors, which amendments shall be subject to enforcement in accordance the provision of this Ordinance.

SECTION 2. Except as specifically amended by this Ordinance, Ordinance 4-97 shall remain in full force an effect. All ordinances and resolutions and parts of ordinances and resolutions in so far as they are inconsistent herewith, are hereby repealed.

SECTION 3. If any section, sub-section, provision, regulation, limitation, restriction, sentence, clause, phrase or word in this Ordinance is declared by any reason to be illegal, unconstitutional, or invalid by any court of competent jurisdiction, such decision shall not affect or impair the validity of this Ordinance or Ordinance 4-97.

SECTION 4. This Ordinance shall become effective in accordance with law.
