ORDINANCE NO. 5 - 2016

AN ORDINANCE OF THE TOWNSHIP OF MIDDLESEX,
CUMBERLAND COUNTY, PENNSYLVANIA, AMENDING
THE MIDDLESEX TOWNSHIP ZONING ORDINANCE TO
PROVIDE FOR PRODUCTION AND PROCESSING OF
MEDICAL MARIJUANA IN THE RF RESIDENTIAL FARM
ZONING DISTRICT.

BE IT HEREBY ENACTED AND ORDAINED and it is hereby enacted by the Board of Township Supervisors in and for the Township of Middlesex, Cumberland County, Pennsylvania, as follows:

SECTION 1: The Middlesex Township Zoning Ordinance is hereby amended as follows:

- A. Section 2.03 [Terms Defined] of Article II [Definitions] is hereby amended to include the following new definitions in appropriate alphabetical order:

Medical Marijuana - Marijuana for certified medical use as set forth in Pennsylvania Act 16 of 2016.

Grower/Processor - A person, including a natural person, corporation, partnership, association, trust or other entity, or any combination thereof, which holds a permit from the Department of Health of the Commonwealth under Pennsylvania Act 16 of 2016, to grow and process medical marijuana. The term does not include a health care medical marijuana organization under Chapter 19, Research Program.

- B. Article VI, RF – Residential Farm Districts, Section 6.02 [Permitted Uses], is hereby amended to include the following new permitted use as follows:

- I. Medical Marijuana Grower/Processor, subject to compliance with all Pennsylvania statutory laws and regulations and Middlesex Township zoning and land use requirements.

SECTION 2: Except only as amended, modified and changed herein, the Middlesex Township Zoning Ordinance as originally enacted and previously amended shall remain in all other respects in full force and effect.

SECTION 3: The provisions of this Ordinance shall be severable. If any of its provisions shall be held to be unconstitutional, illegal or otherwise invalid, that decision shall not affect the remaining provisions of this Ordinance or of the Middlesex Township Zoning Ordinance.

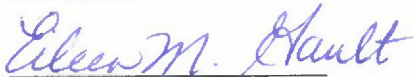
SECTION 4: In the event any provision added by this Ordinance to the Middlesex Township Zoning Ordinance has been numbered, lettered or otherwise designated out of sequence, same shall be corrected and/or correctly numbered, lettered or designated upon discovery of same.

SECTION 5: This Ordinance shall become effective in accordance with applicable law.
