A RESOLUTION OF THE BOARD OF TOWNSHIP SUPERVISORS OF
MIDDLESEX TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA
AMENDING RESOLUTION NO. 2002-6 PERTAINING TO THE ACCEPTANCE
OF LAND OF LARRY R. CLAYCOMB AND ANN C. CLAYCOMB IN THE
AGRICULTURAL SECURITY AREA.

WHEREAS, certain farmland within Middlesex Township has heretofore been
designated and established as an Agricultural Security Area according to the Agricultural Area
Security Law (Act of 1981, P.L. 128, No. 43, 3 P.S. § 901. et seq., as amended); and

WHEREAS, the Board of Supervisors of Middlesex Township by Resolution No. 2002-6
noted certain lands as declared to be and accepted as being part of the Agricultural Security
Area; and

WHEREAS, Resolution No. 2002-6 which was recorded on October 4, 2002 in the Office
of the Recorder of Deeds in and for Cumberland County, Pennsylvania in Miscellaneous Book
690, Page 3702 erroneously identified "Larry L. Claycomb" as an owner of property at 141
North Middlesex Road, Carlisle, whose property, which is also owned by his wife, Ann C.
Claycomb, was declared in said Resolution to be accepted as part of the Agricultural Security
Area.

NOW THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors of
Middlesex Township as follows:

1. Resolution No. 2002-6 is hereby amended for the limited purposes of correctly
identifying the owners of the following property as being a part of the Agricultural Security
Area:

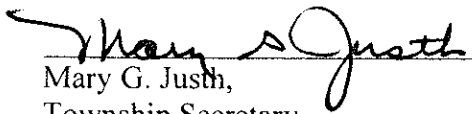
