RESOLUTION NO. 2009- 16

A RESOLUTION OF THE BOARD OF TOWNSHIP
SUPERVISORS OF MIDDLESEX TOWNSHIP, CUMBERLAND
COUNTY, PENNSYLVANIA ESTABLISHING THE FOOT FRONT
ASSESSMENT FOR LIGHTING IN STREET LIGHT DISTRICT 1
IN MIDDLESEX TOWNSHIP FOR THE YEAR 2010.

WHEREAS, pursuant to Ordinance 11-97, the Board of Township Supervisors of Middlesex Township, Cumberland County, Pennsylvania established Street Light District 1 within Middlesex Township; and

WHEREAS, pursuant to the aforementioned ordinance, the costs of providing lighting by street lights within Street Light District 1 shall be paid through a uniform annual assessment in proportion to the number of feet each property fronts on U.S. Route 11 within Street Light District 1; and

WHEREAS, the Board of Township Supervisors of Middlesex Township has determined that the costs for providing streets lights within Street Light District 1 for the calendar year 2010 is \$10,884.16;

NOW THEREFORE, it is hereby RESOLVED by the Board of Township Supervisors as follows:

1. The assessment for 2010 for each parcel within Street Light District 1 based on the foot frontage of the parcel shall be as follows:

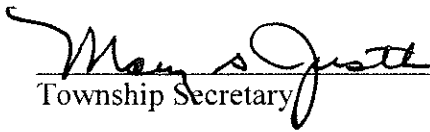

2. This Resolution shall be filed with the Township Tax Collector for purposes of including the above assessments with the annual real estate tax bills for each parcel identified.

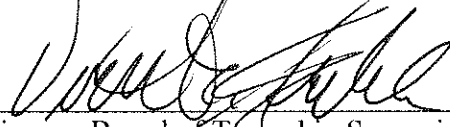
