A RESOLUTION OF THE BOARD OF SUPERVISORS OF MIDDLESEX TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA, ACCEPTING AND INCLUDING LAND OF RALPH L. DEITCH AND LINDA K. DEITCH IN THE AGRICULTURAL SECURITY AREA.

WHEREAS, certain farmland within Middlesex Township has been designated and established as an Agricultural Security Area according to the Agricultural Area Security Law (Act of 1981, P.L. 128, No. 43, P.S. § 901, et seq., as amended); and

WHEREAS, the Board of Supervisors of Middlesex Township has received a proposal by Ralph L. Deitch and Linda K. Deitch to include farmland owned by them and located in Middlesex Township in the Agricultural Security Area; and

WHEREAS, the proposal has been properly acted upon as required by applicable law or certain approvals have been deemed given by passage of relevant time periods as set forth in the Agricultural Area Security Law.

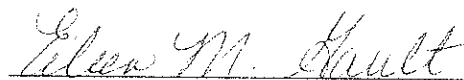
