A RESOLUTION OF THE BOARD OF TOWNSHIP SUPERVISORS OF
MIDDLESEX TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA
ACCEPTING AND INCLUDING CERTAIN REAL ESTATE OWNED BY
CHARLES C. SMITH AND REGINA W. SMITH IN THE AGRICULTURAL
SECURITY AREA

WHEREAS, certain farmland within Middlesex Township has heretofore been
designated and established as an Agricultural Security Area according to the Agricultural Area
Security Law (Act of 1981, P.L. 128, No. 43, 3 P.S. § 901, et seq., as amended); and

WHEREAS the Board of Supervisors of Middlesex Township has received a proposal
from Charles C. Smith and Regina W. Smith to include farmland owned by them and located in
Middlesex Township to be included in the Agricultural Security Area; and

WHEREAS, the proposal submitted has been acted upon as required by applicable law or
certain approvals have been deemed given by the passage of relevant time periods as set forth in
the Agricultural Area Security Law.

NOW THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors of
Middlesex Township as follows:

1. The following real estate described and identified below by property owner name, address, parcel number and acreage is declared to be and is accepted as being in and part of the Agricultural Security Area:

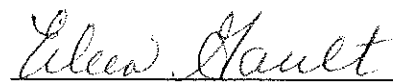
2. This Resolution or a certified copy thereof shall be recorded in the Office of the Recorder of Deeds in and for Cumberland County and properly indexed therein.
