RESOLUTION FOR PLAN REVISION FOR NEW LAND DEVELOPMENT

RESOLUTION OF THE (SUPERVISORS) (COMMISSIONERS) (COUNCILMEN) of Middlesex
TOWNSHIP (BOROUGH) (CITY); Cumberland COUNTY, PENNSYLVANIA (hereinafter "the municipality").
