MIDDLESEX TOWNSHIP RESOLUTION 2021 – 3

WHEREAS, Middlesex Township, by Ordinance 3-92, entered into an agreement, dated April 24, 1992, with the Pennsylvania Municipal Retirement Board to provide a police pension plan; and

WHEREAS, Paragraph 8 of said Agreement allows for the Township to annually waive or reduce the required employee contribution; and

WHEREAS, Middlesex Township seeks to formally acknowledge that for calendar year 2021 the members shall be required to contribute only zero (0%) of compensation.

NOW, THEREFORE, BE IT RESOLVED this 6th day of January 2021 that in accordance with Ordinance No. 3-92 and the Agreement dated April 24, 1992, that Township agrees to reduce the required member contribution to the police pension plan for the calendar year 2021; and

FURTHER BE IT RESOLVED, that a copy of this resolution shall be filed with the Pennsylvania Municipal Retirement Board to so indicate the Township's intent.
