RESOLUTION NO. 2025 - 9

A RESOLUTION OF THE BOARD OF TOWNSHIP
SUPERVISORS OF MIDDLESEX TOWNSHIP, CUMBERLAND
COUNTY, PENNSYLVANIA ESTABLISHING THE FOOT FRONT
ASSESSMENTS FOR LIGHTING FOR PARCELS IN STREET LIGHT
DISTRICT 1 AND STREET LIGHT DISTRICT 2 IN MIDDLESEX
TOWNSHIP FOR THE YEAR 2026.

WHEREAS, pursuant to Ordinance 11-97, the Board of Township Supervisors of Middlesex Township, Cumberland County, Pennsylvania established Street Light District 1 within Middlesex Township; and

WHEREAS, pursuant to Ordinance 4-2013, the Board of Township Supervisors of Middlesex Township, Cumberland County, Pennsylvania established Street Light District 2 within Middlesex Township; and

WHEREAS, pursuant to Ordinance 4-2020, the Board of Township Supervisors amended Ordinance 4-2013 to include additional properties within Street Light District 2; and

WHEREAS, pursuant to the aforementioned ordinances, the costs of providing lighting by street lights within Street Light District 1 and Street Light District 2 shall be paid through a uniform annual assessment in proportion to the number of feet each property fronts on the streets within the specified street light district; and

WHEREAS, the Board of Township Supervisors of Middlesex Township has determined that the costs for providing street lights within Street Light District 1 for the calendar year 2026 is \$12,391.54 based upon a foot frontage assessment of \$1.22 per foot; and

WHEREAS, the Board of Township Supervisors of Middlesex Township has determined that the costs for providing street lights within Street Light District 2 for the calendar year 2026 is \$12,027.02 based upon a foot frontage assessment of \$1.05 per foot.

NOW THEREFORE, it is hereby RESOLVED by the Board of Township Supervisors as follows:

1. The assessment for 2026 for each parcel within Street Light District 1 based on the foot frontage of the parcel shall be as follows:

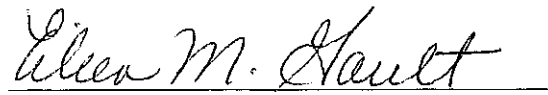
3. This Resolution shall be filed with the Township Tax Collector for purposes of including the above assessments with the annual real estate tax bills for each parcel identified.

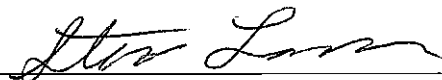
