No. 4-2025, section 5, with a detailed description of the proposed fireworks display or use event, including at least the following required information: Proposed date, time and location of the display or use event, proposed character and duration of the display or use event, name and address of the required competent operator of fireworks display or use event, name and address of the owner or owners of the property on which the fireworks display or use event is to be held including written consent of the property owner or owners, copy of any permit

As required in Ord. No. 4-2025, Section 4.C.3., the applicant must provide evidence to Middlesex Township that the applicant carries insurance in an amount no less than \$1,000,000, conditioned for the payment of any and all damages caused to any person or persons and to any property by reason of the Display Fireworks use arising from any acts of the applicant and his, her or its agents, employees, subcontractors or volunteers. The required evidence of adequate insurance coverage by the applicant shall be in a form acceptable to the Township, and no permit for the display or use of Display Fireworks shall be issued unless such evidence in a form deemed acceptable to the Board of Supervisors is received by the Township.

PROPOSED DISPLAY FIREWORKS EVENT – APPLICATION FOR PERMIT EXTENSION

Is this an application for permit extension for a Display Fireworks display and use event that was cancelled due to circumstances beyond the control of the applicant? _____

As required in Ord. No. 4-2025, Section 4.D., applicants for permit extension must apply within 24 hours after the date and time of the permitted Display Fireworks display and use event and provide all required information and documentation in the original application.

The applicant must describe in detail under oath the fact that the permitted Display Fireworks display and use event was not made on the approved date and time, the reason the Display Fireworks display and use event did not take place, and request an extension of the Display Fireworks use or display event permit for a day no later than seven (7) days after the day fixed for the Display Firework use and display event originally provided in the permit.

By signature of this application, I hereby acknowledge that I have read and reviewed Township Ordinance No. 4-2025 and agree to comply with all requirements therein. I understand that the display or use of fireworks must be handled, arranged, managed and directly supervised by a competent operator. I understand that the Board of Supervisors will have a designated agent inspect the site of the proposed fireworks use or display as part of this application. I understand that the Board of Supervisors may attach additional conditions and/or restrictions on any permit for the use or display of fireworks as it deems necessary. I verify that the statements in this application and any supporting documents provided are true, accurate and complete. I acknowledge that any false statements or information provided by me herein are made under penalty of punishment by law.
